additional comments :

- Marsh Europe (accounted under Marsh McLennan) : 2023 not published; account 2022 is used instead (for 2022 and 2023 figures)

- Tysers Belgium : the latest reporting refers to Jan. 2022, up to and including June 2023. A pro-rata (2/3) was used for both 2022 and 2023 figures
- Ambris Europe : the latest publication refers to Jan.2023, up to and including March 2024. A prorata (4/5) was used for 2023 figures
- Howden : 2022 figures refers to the fiscal year (Oct. 2021-Sept. 2022) and 2023 figures refer to (Oct. 2022-Sept. 2023)
- Concordia : Revenue and turnover as reported by CEO
- Orbis Risk Partners : Turnover and total revenue as reported by Finance manager.

- Allia Insurance brokers: CEO reported the additional turnover generated through their LU and CH office. The ranking relative to their peers remains unchanged, regardless of whether these additional figures are included or not. The LU and CH figures have not been summed, in order to avoid distorting their growth figure (growth hence, only for BE).

*If the operating revenue and turnover is not available, reference is made to the gross margin (referenced with *);

*Reference is made to consolidated accounts if available. If no consolidated accounts are available, but separate entities are known to be part of the group, the results of the various entities are added up (confirmed in the footnote);

*Revenue and Turnover do include foreign branches if applicable. FTE are Belgian payroll only;

*Non-recurring operating income can be accounted for in different ways, depending on the company's accounting policies. These revenues may either be recognized as turnover all at once, as a lump sum, or they might be spread over multiple periods. This treatment can have an impact on the analysis;

The ranking

BVVM-UPCA has consistently published these industry rankings based on total company revenue (when available), including foreign earnings and non-recurring income.

For 2023, we've introduced an alternative ranking based on turnover. Where possible, we have distinguished between Belgian turnover and turnover from foreign branches or affiliates.

To enhance interpretability, two additional metrics are included:

Cost Ratio: Calculated as the percentage of company costs (excluding non-recurring costs) relative to company income (excluding non-recurring income). If insufficient data is available to calculate this ratio, it is marked as Not Available (NA).

Turnover per FTE: Based on Belgian turnover and reported FTE. The consideration of this ratio, should be nuanced in view of other human capital used by the company (e.g., temporary or independent staff).

This ranking of the top 25 industry participants is based on publicly available information and select additional confirmations. While every effort has been made to ensure accuracy, some financial figures may be unavailable, incomplete, or not directly comparable across participants due to differences in reporting practices or data limitations. Also, relevant information may have been unintentionally omitted.

This list is intended as a general industry overview and should be interpreted with these limitations in mind. We recommend using this ranking as one of several resources for understanding the industry landscape.
